## About Speaker:

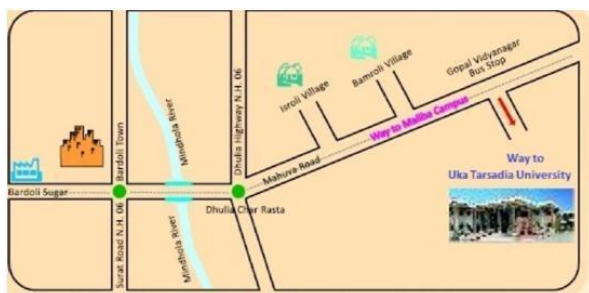
