**1. Introduction**

As a partial requirement for the award of the degree of M.C.A./MSc.(CA) at UkaTarsadia University, a dissertation submission will be carried out by students in their 4<sup>th</sup> and 5<sup>th</sup> semester of study.

The dissertation provides the students with the opportunity to analyze, design, under-take or conduct an independent piece of innovative work or study related to their area of interest under the guidance of a guide. It required a review of the literature on the subject matter, the investigation/planning and methodology, the results and findings, and concrete recommendations and conclusions which is to be present and discuss concisely and clearly.

**2. Time and Duration:**

1. A student has to strictly follow the deadlines given from time to time.
2. For better execution, dissertation work plan shall be prepared by the team and submitted to the dissertation guide within a maximum of 7 days of the start of the dissertation.
3. In case, of failure to meet the deadlines, a student shall be restricted to appear in Internal/External Dissertation Viva.

**3. Team Constituted and Guide allocation:**

1. Student shall continue with the same dissertation team as that fixed in the 4th semester.
2. Student team shall continue their dissertation work on the topic fixed in the 4th semester.
3. The guiding team shall be the same as that of allocated in the 4th semester.
4. The change of guide shall be allowed only if that guide is no more associated with the institute.
5. Re-allocation of the guide with respect to (4) shall be done by Dissertation Co-ordinator after approval by the Director.

#### 4. Reporting:

1. A student shall report about the progress in dissertation work to the dissertation guide atleast once a week.
2. A student shall submit at least 3 dissertation summary reports to dissertation guide indicating his/her progress.
3. For any query, a student can approach to the Dissertation Guide and Co-ordinator.
4. A student shall maintain a log book to help them to plan their own dissertation and to record the outcomes timely. Following is the format of the log book.

##### A1 guidelines

- During presentation, students may use their own laptop for presentation and demonstration of related work.
- A student shall propose a solution for the problem identified.
- Solution can be a minor or major modification to existing techniques and/or application of existing technique/methodology/approach in some new area.
- Student comes with a demonstration, inputs must be given in suggestive mode rather than commenting mode.
- Each presentation shall not exceed time limit of 30 minutes including Viva.
- Guide of the dissertation presenting team will remain present at time of evaluation with other panel member(s).
- After the presentations, panel member shall submit evaluationsheets soft copy and hard copy with signatures of all panel members with in given time to assigned person by RDC committee.
- RDC committee will provide evaluation sheets in advance.

- Evaluating team members shall decide time and venue for the presentation and shall share the same with student teams.
- Once schedule is finalized by the evaluation panel, students are bound to give presentation within time schedule. No excuse of student is going to be considered at all.
- No make-up work shall be accepted for missed or failed presentation.
- First presentation shall be scheduled during **17<sup>th</sup> to 20<sup>th</sup> August, 2015.**

**Note: If the examiner feels that the dissertation work has not actually being done by the student then he/she can allot zero marks for the same.**

## 5. Report

The dissertation work carried out during the term shall be submitted at the end of the 5<sup>th</sup> Semester in the form of a dissertation written by the student. The dissertation should be typed and may include relevant diagrams, figures, photographs, illustrations, tables and appendices. The dissertation should consist of preliminaries, main text and references/appendices. No plagiarism is allowed.

### A. Preliminaries

The preliminaries should abide by the following order, wherever applicable:

#### ➤ Title Page

The title page of the dissertation should be in format given in Annexure I.

#### ➤ Dissertation Certification Form

[The form should be signed by programme co-ordinator.] The dissertation certification form should be in format given in Annexure II.

#### ➤ Declaration of Student as well as Guide Form

[The form should be duly filled signed by the students and guide.] The declaration of student and guide should be in format given in Annexure III and IV.

#### ➤ Table of Contents

The Table of Contents shall list in sequence with page numbers all chapters, sections/headings, sub-sections/headings and other sub-divisions of the dissertation, appendices, etc.

#### ➤ List of Tables, Figures, Schemes

Separate lists of each, in the above order, giving number and page reference.

#### ➤ Abstract

The abstract constitutes an up to one-page executive summary, which provides a brief outline of the objectives, scope of the dissertation, the methodology used, the main findings and results achieved and any conclusions and recommendations made.

#### ➤ List of Abbreviations

This section should list in alphabetical order all abbreviations used in the dissertation.

### B. Main Text

The main text of the dissertation should start with an introduction followed by chapters, subdivided into sections and sub-sections. Depending on the scope appropriate chapters may include amongst others:

1. Literature Review,
2. Methodology,
3. Experiments and Analysis
4. Conclusions
5. Future Enhancements
6. "Learning during Dissertation Work", i.e. "Experience of Journey during Dissertation Duration"  
[Limit up to two paragraphs]

Any table, figure, illustration included in the dissertation should be clearly labeled. The caption should be placed at the top of tables but below figures/illustrations.

### **C. Guideline for Report Formatting:**

- Use A4 size page with 1" margin all sides
- Header should include Dissertation title and footer should contain page number and enrollment numbers
- Chapter Name should be of Cambria font, 20 points
- Main Heading should be of Cambria font, 16 points
- Sub Heading should be of Cambria font, 12 points, Italic
- Paragraph should be of Cambria font, 12 points
- Line spacing - 1.5, before - 0, after - 0
- No chapter number for references
- Before chapter 1, give page number in roman letter

### **D. References/Appendices**

The list of references should follow the main text.

1. Documentation Reference Style: IEEE referencing standards shall be followed.

The appendices shall consist of any base material, which would break the flow of the dissertation due to its length or partial irrelevance. Some examples are:

1. Raw data
2. Survey sheets
3. Charts and data tables from books
4. Lengthy mathematical derivations

All appendices should be listed in sequence, i.e. Appendix 1, 2, 3, etc.

### **E. Physical format and layout**

1. Certificate shall be collected from dissertation team during 29th September, 2015.
